

ПЕРСПЕКТИВЫ РАЗВИТИЯ ГЕРОНТОЛИНГВИСТИЧЕСКОЙ ПАРАДИГМЫ ЗНАНИЯ

Введение. Цель данной статьи состоит в актуализации социального взгляда на феномен старения. В статье осуществляется обзор современных зарубежных исследований, посвящённых анализу социальных аспектов старения. Автор описывает наиболее значимые темы этой области исследований. В статье рассматривается формирование научного интереса к изучению языковой опосредованности феномена старения. Анализируются причины востребованности геронтолингвистических знаний, приводятся аргументы, обосновывающие их актуальность.

Методы. Основу исследования составляют общенаучные методы познания (анализ, синтез, логические методы).

Основные идеи исследования, полученные результаты и их обсуждение. В статье рассматривается становление научного интереса к исследованию языкового опосредования феномена старения. Анализируются причины востребованности геронтолингвистического знания, приводятся доводы, обосновывающие его актуальность. Описываются основные направления исследований связи языка и процесса старения, а также существующие интерпретации термина «геронтолингвистика».

Заключение. По результатам исследования сделан вывод о том, что геронтолингвистика становится междисциплинарной областью, аккумулирующей усилия всего корпуса геронтологического знания, направленного как на поддержание языкового здоровья стареющего населения, так и на реализацию стратегии активного и здорового старения в условиях перехода к гипервзрастному обществу.
